Mr. Ramsey earned a bachelor's degree from Florida State University where he graduated summa cum laude. In 1981, he earned a Juris Doctorate, with honors, from the University of Florida College of Law where he was a member of the Board of Editors of the Law Review. Upon entering practice, he rapidly achieved an AV-rating from Martindale-Hubbell and subsequent peer election into the American Board of Trial Advocates (ABOTA). Mr. Ramsey has been recognized as America's Top 100 Attorneys and is included among the 5% of Florida attorneys listed in Florida Super Lawyers. Recognitions also include Top Lawyer in South Florida Legal Guide, Florida's Legal Elite in Florida Trend and Palm Beach Illustrated Top Lawyer.
